Board of Commissioners New Business

Green Pond Traditions of America – Final Plan Revision – The applicant is proposing to revise the previously approved and recorded plan. The revised plan switches the single units 18 and 19 with the twin units 35 and 36. Per the Township's Subdivision and Land Development Ordinance, this revision represents a change to a recorded plan and therefore needs to be reviewed by the Planning Commission and Board of Commissioners. The Planning Commission recommended granting conditional approval at its' December 21, 2021 meeting.

Birchwood Commons Deed of Dedication -12^{th} Street - As part of the Birchwood Commons development, the applicant was required to improve 12^{th} Street along their frontage.
