Pre-Application Meeting

There was one pre-application meeting this month.

3608 Nazareth Pike (former Leiser's property) – The applicant proposes a convenience store with associated gas pumps on the corner of Route 191 and Oakland Road. The Township Staff and Planning Commissioners, present at the meeting, discussed the access and layout. This is the second time reviewing this plan. Discussion surrounding stormwater discharge and expressed a desire to minimize access points to Route 191. There are some zoning issues as well.

Zoning Definition Text Amendments

The Township Zoning Officer has recommended a number of changes in the definitions section of the Zoning Ordinance. Some of these definitions were also identified by previous Zoning Officers.

Reasons for updates include modernizing language and clarifying purpose. No substantive changes are being proposed, rather current language is being sharpened.

The Zoning Officer worked with the Planning Director, Thomas Comitta and Associates and the Township Solicitor to draft the amendments that are presented. In response to Commissioner's comments on October 4, the definitions for "family" and "dwelling unit" were revised.
