CALL TO ORDER Mr. Merhottein called the meeting to order at 7:00 p.m. and led those assembled in the Pledge of Allegiance.

APPROVAL OF MINUTES Upon motion (Gallagher-Deckman), the Board of Commissioners voted unanimously by voice vote to approve the January 19, 2026 regular public meeting minutes. Mr. Hudak was absent.

Casey LaLonde, project manager for Herbert, Rowland & Grubic, the township's stormwater engineer, presented an overview and update on the township's stormwater program and capital improvement plan.

3942 KENRICK DR.** Mr. Kreier asked about present and future stormwater projects. Mr. LaLonde said the next projects coming up are Sculac Drive stream restoration and Phase 1A of the Easton Avenue flood mitigation project.

4323 CHETWIN TERR.** Mr. Roth said the eastern end of Ohio Street and Chetwin Terrace have severe flooding issues.

MOTION **A MOTION AUTHORIZING THE TOWNSHIP MANAGER TO ADVERTISE THE BETHLEHEM TOWNSHIP - EMERGENCY TRAFFIC SIGNALS (SR 2018) FREEMANSBURG AVENUE AND 9TH STREET - 1-21-26 - DESIGN SUMMARY FOR PUBLIC BID**

Mr. Gawlik explained that the emergency preemption light is similar to the one Nancy Run Fire Company. It will allow safer passage of emergency vehicles from Bethlehem Township Volunteer Fire Company's station onto Freemansburg Avenue. Mr. Gallagher asked if certain lights would be red. Mr. Gawlik said all will be red. Mr. Deckman asked how much grant money

was received. Mr. Merhottein said \$450,000 in state funding. Mr. Gawlik said he hope it will cover the expenses.

Upon motion (Deckman-Lawrence), the Board of Commissioners voted unanimously by voice vote authorizing the township manager to advertise the Bethlehem Township - Emergency Traffic Signals (SR 2018) Freemansburg Avenue and 9th Street - 1-21-26 - Design Summary for public bid. Mr. Hudak was absent.
